Examples of Entry Level Jobs as a Sanitarian

Sanitarian I (or Inspector I)

- Performs inspections and investigations involving food manufacturers, food wholesalers/warehouses, food salvage establishments, and public environmental facilities that operate recreational or public sanitation type facilities.
- Prepares inspection reports that may include photos, samples, and other exhibits to document inspectional findings using word processing, database, and other computer software.
- Investigates consumer complaints concerning regulated program facilities; investigates food borne illness outbreaks and prepares related reports and evaluations.

Environmental Protection Specialist I

- Performs inspections and investigations involving food manufacturers, food wholesalers/warehouses, food salvage establishments, and public environmental facilities that operate recreational or public sanitation type facilities.
- Provides information and assistance on food and drug related subjects as requested by citizens, regulated industry, and other local, state, and federal agencies.
- Prepares technical presentations on applicable subject for Division training programs, as requested. Participates in available educational programs and training presented by the division, the U.S. Food and Drug Administration, the Department, and additional outside training as directed.

Interested in next steps? Consider licensure as a Registered Sanitarian, a certification that is sometimes required and always preferred. Positions that do not initially require a sanitarian certification will often require candidates to become certified after onboarding.
