 Youth Camp rule revision items suggested by committee from the previous meeting, program updates. (Jeff Mantia)



Program recommendations

 a. Horseback riding program rule requirement 265.17(f)(2)(C) for campers and instructional staff to wear helmets. Request this rule be removed or made optional for staff to wear helmets.

Program decision is to keep rule as it is currently written with no change.



Program recommendations

 b. Provide options, under rule 265.15(a) on-call physician, to include on-call Physician's Assistant (PA), or on-call Nurse Practitioner (NP).

Program decision is to include this edit in a current rule revision project.



Program recommendations

• c. Clarify whether a camp health officer is required for fields trips, when some campers remain at the camp facility. Program decision to add a requirement for an adult staff member currently certified in AED, CPR, and first-aid to accompany campers on off-site field trips in the current rule revision project.

Program decision is to include this edit in a current rule revision project.
